Dear Rev. Knox:

Thank you for registering with the Charlotte County Clerk of the Circuit Court to be a premarital course provider.

Florida statutes 741.0305 states that couples who want to apply for a marriage license may have the fee reduced to \$56.00 if they complete a premarital preparation course of not less than 4 hours and provide the Clerk's office with their completion certificate. They may take the course together or separately, but the course must have been taken within a year of applying for the license. The cost of the course is to be paid by the applicants.

Per Florida statutes 741-0305 (4): the provider will furnish a completion certificate to each participant specifying the name of the participant, the date of course completion and whether the course was completed by personal instruction, videotape instruction or instruction via other electronic medium, or by a combination of these methods.

Please be sure this information is on the certificate you provide to the participant upon completion of the premarital preparation course.
